1. Background

Swisscontact is an independent, non-profit Swiss foundation dedicated to promoting economic, social, and environmental development. Swisscontact's development work focuses on private sector-led, sustainable economic development with improved quality of life for all in developing and emerging countries. A key focus is to strengthen the skills of individuals and foster the competitiveness of companies. Swisscontact is implementing "Perspektiva të Reja" Project in Kukes, Has, Tropoje and Diber Municipalities. The Perspektiva të Reja project (NP Project), funded by the UK Government and implemented by Swisscontact with TAG International, aims to reduce the number of Albanians who migrate to the UK via irregular means. The project focuses on changing attitudes, creating economic opportunities, and improving the enabling environment for economic development and the social contract.

2. Context of the Assignment/Rationale

NP Project needs to provide and implement three interventions as mentioned above in the request for proposal. During the implementation of the project and the interventions realised from the project it is noticed the need of providing the young persons with skills, capacities and providing them with the opportunity to access the labour market. Vitalisation of the social and cultural life of young persons as well as enabling them to propose and organise on their own youth activities. Based as well on the recommendations coming out from the inception studies developed within the project location it was clearly mentioned and put into attention the importance of having in the municipalities:

- strategy and an action plan for on-job training of local employees in selectedprofessions such as cooks, tour guides, etc. Support upskilling and certification of local guides too.
- Provide coaching, mentoring, and technical advice to businesses supported by the project.

3. Scope of the work and Deliverables

New Perspectives aims to identify a local service provider aiming at:

- Capaicty builing / training on digital marketing nd create opportunities for young persons to have an apprenticeship in national / international companies. At least two groups composed by 15 young persons each (1 for Kukes and 1 in Tropoja).
- Empowering of women from marginalised groups, by providing them with skills that will facilitate their integration into the labor market and encourage entrepreneurial activities. At least two groups of women and girls composed by









15 persons each (for Kukes). A needs assessment will be conducted with these team before starting their training or providing of the skills.

- Enabling and facilitating the implementation of the youth engagement activities. 4 youth activities in total, one for each municipality.

Deliverables for each of the intervention should include:

- Baseline questionariees and datas.
- Agendas of the activities (training, meetings, youth engagement activity etc.).
- CVs of the team responsables for organising and delivering of the activities.
- Ensuring all the documents related with the realisation of the interventions (booking of the premises, list presences for each activity, meeting etc.)
- Providing of the curricula for each activity.
- Handouts / curricula for each intervention.
- Selecting together with the NP team the candidates and provide in final the list of the selected candidates.
- Contracts with third parties / participants (as per discussions with NP team)
- Reporting in the end of the realisation of the activity.
- Approval from Component Coordinators for execution of the deliverables

4. Eligibility criteria

This call is opened for registered entities/companies/NGOs. In order to be eligible for the service, the service provider must satisfy the following obligatory requirements:

- ➤ Be officially registered at the national business center with respective required certificates (NUIS and QKB extract documents to be provided);
- ➤ Have at least 3 years previous experience as entity/company in related required services.
- Applicants will be encoraged to secure co-financing of 15% of the total amount requested in the open call.
- > Have at least 3 years previous experience in providing reports writing resources.
- ➤ Have **proven field experience** in the municipalities where the NP project operates: Kukes, Has, Diber and Tropoje.

 - Financial Proposal must be submitted disaggregated by operative costs. Lump Sums will not be accepted. Please provide a description of items and prices per unit. Prices shall be provided in ALL. VAT amount to be indicated separately.

The application MUST contain all required documentation, otherwise may be automatically eliminated by Swisscontact without a further request for clarification and/or completion.

6. Evaluation process

An evaluation panel, consisting of no less than 3 (three) members, will evaluate the applications as per the criteria informed in this tender document.
